Release

I, the undersigned, assume all of the risks inherent in, as well as those that could potentially stem from, the farm animal activities that I will be engaging in and in the proximity of. These include, but are not limited to, the risk of property damage, bodily injury, and physical harm to myself, my family members, or anyone else present. I realize that all types of farm animal related activities are inherently dangerous and can even be fatal. Therefore, I understand that my, or my family member's, participation in a "farm animal activity," as defined by the applicable laws, is wholly at my own, or their own, risk. I understand that my, or my family member's, participation involves all of the risks inherently associated with the dangers and conditions that are an unavoidable part of the farm animal activities themselves. These include, but again are not limited to, the propensity of an equine to behave in ways that may result in personal injury or death to a person on or around it, the unpredictability of an equine's reaction to sound, sudden movement, unfamiliar objects, persons or another animal, hazards related to land conditions, collisions with other equines, objects or animals, and the potential for another participant to act in a negligent or unskilled manner, all of which may contribute to injury to the participant or others.

I acknowledge that it is my responsibility to carry full and complete insurance coverage for myself, my family members, my guests, and my personal property (including any equine of mine). I am aware that my own insurance coverage should be comprised of, at a minimum, adequate medical insurance, life insurance, and accident insurance.

I agree to assume any and all risks, and the potential damages associated with those risks, involved in or arising from my own, my family members, or my guests use and/or presence upon the property and facilities owned or leased by Joe Beaver Inc. By way of example, these risks include but are not limited to the risk of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire, explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.

I agree to hold Joe Beaver Inc. and its managers, members, partners, successors, assigns, subsidiaries, affiliates, officers, directors, employees, equine instructors, and agents completely harmless from any and all expenses and costs (including attorney's fees and litigation costs) associated with any harm that may befall me while participating in or being in close proximity to these farm animal activities. I further understand that Joe Beaver Inc. is not liable for any damages I may suffer while engaging in or spectating these farm animal activities, regardless of the cause of those damages. I fully and completely release Joe Beaver Inc. from any and all liability whatsoever and agree not to file a lawsuit against it or any of its aforementioned related parties on account of or in connection with any claims, causes of action, injuries, damages, costs or expenses arising out of my, my family members, or my guests' use of or presence upon the property or facilities owned or leased by Joe Beaver Inc. This includes, without limitation, potential damages stemming from death, bodily injury, property damage, consequential damages and any punitive damages. I agree that I can represent and will be responsible for any minors under my care or control on Joe Beaver Inc's premises and, to the extent allowable, release any claims that they may have for any damages and injuries as well.

I agree to indemnify and defend Joe Beaver Inc., its managers, members, partners, successors, assigns, subsidiaries, officers, directors, employees, equine instructors, and agents against, and to hold harmless from, any and all claims, causes of action, damages, judgments, costs, and expenses that in any way arise from my, my family members, or my guests' activities on the property owned or leased by Joe Beaver Inc.

I acknowledge that I have read a copy of Joe Beaver Inc's Rules and agree to abide by the same. This agreement is made and entered into under the understanding that the laws of the State of Texas are to apply to any dispute arising from my or my family members' participation in this farm animal activity. Should any clause of this agreement be deemed void by a court of law, then it is understood that the remainder of this agreement shall continue to be valid and enforceable.

This agreement is binding on the heirs, executors, personal representatives, administrators, family members, guardians, successors, assigns and dependents of the undersigned.
